Old Business

1. 2010 Invitational Tournament - March 27, 2010 - South YMCA Farha Sports Center
 - 5 p.m. Friday Mat Delivery; 7 a.m. Sat Setup (Bumped back from 6 a.m. due to smooth operations provided by past team leaders – hope to count on same folks as team leaders again this year)
 - Sign-up Rosters to be circulated Feb Belt Test and also provided for Instructors to take to classes to recruit non-black belt help. Instructors – begin talking up participation to classes; in addition to student participation emphasize that many roles can be filled by non-students and non-black belts. (Admission fee is deferred for participants in supporting roles) **NOTE – Black Belts signing up for ring participation please do not accept other assignments which would pull you away from your rings.**
 - a. Setup/Cleanup (includes returning YMCA tables and chairs to main building across parking lot)
 - b. Judges/Referees
 - c. Time Keepers/Runners
 - d. T-Shirt Table workers
 - e. Lunch Room Managers
 - To control traffic in the Referee Lunchroom (and to still have food available for the late-running rings) the doors closest to the gym will be closed, the windows blocked, and referees/judges will be directed during referee meeting to use the north doors for access to the lunchroom. Signs will be posted at that entrance indicating room is open to Referee/Judges/Ring Attendants
 - Be aware of trash overflow – please help make YMCA personnel aware when removal is necessary (Mr. Hilburn will look into providing FRS Radios)
 - Sponsorship – Two basic areas of division: Commercial and Individual. Ms. Hilburn will provide handouts at Feb Belt Test to take back to classes informing different levels of sponsorship opportunities available
 - a. Don't discount the small individual donations of \$5 - \$10 – everything helps to defray costs of putting on the tournament
 - b. For Commercial sponsorships be sure to emphasize that their logo artwork for the brochures is needed. A business card to scan is not enough – need the actual artwork. (Goes to Jim Mathias)
 - Texas contingent will be there this year after all – their scheduling conflicts have been resolved
 - Ring Box stocking – Terese Lewis and Cyndy Mundt will check and replenish boxes prior to Feb and March tournaments
 - Rules will continue to be posted on each ring-table; be sure to consult for age/belt variances
 - Remind participants full gear required
2. T-Shirt Order - Full 300 count order will be placed
 - Per last year's experience size distribution will include more Adult L & XL and less Child Small
 - Tournament Text above and below winning design was agreed to be blue at top and red at bottom
